CHAPTER 7 : FINANCIAL REGULATIONS

AMENDMENTS ARE MARKED IN RED

ARTICLE 1 : REGISTRATION FEES

Article 1.1

TEAM REGISTRATION

For each team registering with a view to participate in the European Championships, the respective National Federation shall forward an entry fee of

150.- EURO

The National Federation shall pay an entry fee only UPON RECEIPT of the respective CEV invoice into the bank account of the CEV.

Article 1.2

LICENSE FEE

There are no collective team licenses requested in the competition

Article 1.3

CEV MEDICAL INSURANCE

At the same time the license will be issued, the National Federation shall pay the insurance fee for each athlete and official registered in the 05-bis form, only UPON RECEIPT of the respective CEV invoice and into the bank account of the CEV.

The insurance fee for each athlete and official amounts to

15.50.- EURO

As this insurance fee covers the entire calendar year (01.01. to 31.12) no supplementary costs will be raised in case an official or athlete is involved in more than one CEV volleyball competition.

Article 1.4**ORGANIZATION FEE**

No organization fees are requested in this competition.

Article 1.5**PARTICIPATION FEE**

For each TEAM QUALIFIED for the FINAL ROUND the respective National Federation shall forward, at the latest 30 days before the start of the competition, a participation fee, amounting to

700.- EURO

into the bank account of the CEV.

Article 1.6**CONTRIBUTION FEE**

- 1.5.1 Each National Federation with a team participating in the 1st and 2nd ROUND tournaments must contribute to the board and lodging costs of its delegation, by paying a "unique" fee to the organizing National Federation for each member of its delegation (max. 17 persons). The amount of this "unique fee" (resulting from the number of days x 50.- EURO) is

200.- EURO (tournament with 3 or 4 teams)

300.- EURO (tournament with 5 or 6 teams)

This amount must be paid upon arrival of the team and must be settled even if the duration of the stay is shorter.

- 1.5.2 Each National Federation with a team participating in the FINAL ROUND must contribute to the board and lodging costs of its delegation, by paying a contribution fee to the organizing National Federation for each member of its delegation (max. 18 persons). The amount of this per diem is

50.- EURO

The arrival and departure day account together for 1 day.

Article 1.7

For each delegation qualified to the Final Round, the accommodation costs for the extra person (s) non included in the official composition of the team is fixed to a maximum of :

100.- EURO / per person / per night

ARTICLE 2 : PROTESTS

Article 2.1**FINANCIAL DEPOSIT**

Any protest or claim shall mandatorily be accompanied by a deposit of

300.- EURO

As foreseen in article 2.5 of the General Regulations.

ARTICLE 3 : ORGANIZATION COSTS

Article 3.1**TRANSPORT****3.1.1 TRAVEL EXPENSES OF TEAMS**

3.1.1.1 For the MATCHES/TOURNAMENTS of the 1st and 2nd ROUNDS, each team shall only bear its own return travelling expenses to the official venue of arrival/departure indicated by the organizer of the match/tournament.

The travel expenses from this official venue to the competition site and back, as well as all local transport, shall be borne by the organizing National Federation.

3.1.1.2 For the FINAL ROUND, each team shall only bear its own return travelling costs to the official venue of arrival/departure indicated by the organizing Federation.

All travel expenses within the hosting country, i.e. transportation from this central venue to the other competition sites - and back - shall be borne by the National Federation organizing the final round.

3.1.2 TRAVEL EXPENSES OF CEV OFFICIALS & REFEREES

3.1.2.1 With regard to the matches/tournaments of the 1st and 2nd ROUNDS, the organizing National Federation shall bear the travelling costs for the Referees appointed by the ERC, for the CEV Technical Delegate and the Referee Delegate.

The travelling expenses resulting from the inspection visit provided for under CHAPTER 2: TECHNICAL ORGANIZATION AND LOGISTICS art. 1.2.1.3. shall be borne by the Organizing National Federation.

3.1.2.2 With regard to the FINAL ROUNDS, the organizer shall bear the travelling costs for the following persons:

- the President of the Control Committee ;
- all Jury Members ;
- all Members of the Special Refereeing Commission;
- any other Officials appointed by CEV

For the referees appointed by the ERC from Federations NOT taking part with a team in the Final Round, the organizer shall arrange the travel to the central competition site and back

Referees of Federations whose teams are taking part in the Final Round will not be considered as part of their countries' delegations.

The organizing National Federation shall bear all travelling costs resulting from the co-ordinators' inspection visits and the Drawing of Lots as well as for CEV Officials appointed for the Supervisory Board or for the drawing of Lots.

3.1.3 LOCAL TRANSPORTATION

All travel expenses within the hosting country, i.e. transportation from this central venue to the other competition sites and hotels – and back – shall be borne by the National Federation organizing a match/ tournament in the 1st and 2nd round and final round.

Article 3.2

VISA COSTS

The visa costs (only THOSE to be paid to the consular authorities) are to be paid by the party that pays the travel costs. In case CEV pays the travel ticket, the visa costs are to be paid by the organizer.

Article 3.3

FOOD & LODGING EXPENSES OF TEAMS

3.3.1 For the matches/tournaments in the 1st and 2nd ROUNDS, the organizing National Federation shall bear the accommodation and food costs for 17 persons (12 players, 5 officials) per team for a period starting one day before and ending one day after the match/tournament.

3.3.2 For the FINAL ROUND, the organizing National Federation shall bear the hotel (good category) and food costs for 18 persons (12 players, 5 officials and 1 journalist) per team, not including the one referee possibly appointed by the ERC, for a period starting two days before the beginning of the competition and ending one day after the closing of the final phase / the elimination.

Article 3.4

FOOD & LODGING EXPENSES OF REFEREES & CEV OFFICIALS

- 3.4.1 For the matches/tournaments in the 1st and 2nd ROUNDS, the organizing National Federation shall bear the hotel (good category) and food costs for the referees appointed by the ERC, as well as for the CEV Technical Delegate and Referee Delegate, in single rooms.
The organizing National Federation shall bear all hotel (good category) and food costs incurred by the CEV Technical Delegate in the scope of the inspection visit provided for in CHAPTER 2 – Technical Organization & Logistics / Art. 1.2.1.3
- 3.4.2 For the FINAL ROUND, the organizing National Federation shall also bear the hotel (good category) and food costs for :
- the CEV Representative
 - the President of the Control Committee
 - all Jury Members ;
 - all Members of the Special Refereeing Commission ;
 - the appointed referees;
 - any other CEV Officials or persons (if appointed)
- in single rooms, for a period starting three (3) days respectively two (2) days before start of the tournament and ending one day after the end of the final round.
- The organizing National Federation shall bear all hotel (good category) and food costs resulting from the President of the Control Committee's inspection visits provided for in CHAPTER 2 – Technical Organization & Logistics / Art. 1.2.2.2 as well as for the CEV Officials appointed for the Drawing of Lots.

Article 3.5

PER DIEM

- 3.5.1 During the whole duration of their stay:
- the CEV Technical Delegate, the Referee Delegate and the referees appointed for the 1st and 2nd round MATCHES / TOURNAMENTS or entrusted with inspection visits ;
 - the President of the Control Committee, the Members of the Jury, the Members of the Special Refereeing Commission and the referees, as well as any other Officials nominated by the Executive Committee either appointed for the the Supervisory Board, for the FINAL ROUND or entrusted with inspection visits or appointed for the drawing of lots ;
- shall receive a daily pocket money, amounting to
respectively 75.- EURO
- The day of arrival and the day of departure count each for one full day. In case that no flight connection allows to arrive or depart on the foreseen dates, the related extra Per Diem has to be paid by the organizer. The Per Diem covers all costs of any kind related to the journey.
- 3.5.2 The Per Diem will be borne by the organizing Federation and paid in EURO. The Per Diem shall be paid to its recipient on the very day of the latter's arrival.

ARTICLE 4 : AGREEMENT

Article 4.1

FINANCIAL DISPOSITIONS BETWEEN THE ORGANIZER AND THE CEV

The organization of a Final Round shall be documented in a written agreement between the CEV and the organizing National Federation ; this agreement shall be concluded and signed at the latest 8 [EIGHT] weeks after the CEV has appointed the organizing Federation. Amongst other matters, this agreement will deal with TELEVISION and MARKETING rights, as well as with all financial commitments towards the Organizers and towards the CEV.

ARTICLE 5 : FINANCIAL DAMAGES

Article 5.1

The organizing National Federation is responsible for the financial damages occurred to the CEV and visiting national teams, for mistake or culpable negligence by their careless organisation.

Article 5.2

Costs and damages occurred to CEV and organizing National Federation or to visiting National Team, by force majeure or a reason outside the influence respectively of a visiting national team, CEV or the organizing National Federation, have to be borne by the damaged body itself.

ARTICLE 6 :

FINES & SANCTIONS

ARTICLE 7 :

CASES NOT FORESEEN

All cases not provided for by the current regulations shall be settled by the CEV Executive Committee.
